

Rural Fast Track Grant

Leisure and Hospitality Eligible Counties (updated 6/26/2107)

Below are counties in the state of the third, fourth, fifth, or sixth class as described in Utah Code Section 17-50-501 with Leisure and Hospitality as a percentage of county employment 25% GREATER than the State average of **10.2%**. In these counties, Rural Fast Track Grants be used for hospitality businesses.
