Proposed Rulemaking

R359-1-506. Drug Tests

Administrative changes include:

- a. Update to include the 2011 the World Anti-Doping Agency list for unarmed combatants.
- b. All licensees that are actively participating in an event will be subject to drug testing

*Commissioner Leavitt made a motion to send the proposed rule changes of R359-1-506 for public comment. Commissioner McCartney seconded the motion. Motion passed unanimously.*

### R359-1-102. Definitions

Bill looked to Nevada's definitions and added some additional parameters under unprofessional conduct.

### Contestant Medical Insurance

Many promoters are using XSI to buy their insurance. Each policy is issued by individual name and, if promoters have secured their cards far enough in advance, this insurance works well. If promoters do not secure their cards ahead of time they may not be able to purchase all policies by the event date.

Commissioner Montanez proposed language be added to the insurance rule that no contestants can waive the insurance coverage.

### Director's Report

There is one MMA promoter that was \$65,000 short of paying all fight costs. Only two judge checks cleared. The promoter sent out an urgent message telling individuals not to cash checks. The bonding company covered all the purses and seems to be cooperative. The promoter counted on internet sales that failed.

Bill talked about inspector concerns of overcrowding at Lumpy's downtown.
