

**Rural Fast Track Grant  
Leisure & Hospitality Eligible Counties  
(Updated 10/29/2018)**

Below are counties in the state of the third, fourth, fifth, or sixth class as described in Utah Code Section 17-50-501 with Leisure and Hospitality as a percentage of county employment 25% GREATER than the State average of **9.72%**. In these counties, Rural Fast Track Grants may be used for hospitality businesses that match the list of NAICS listed below.
